TEN OUTSTANDING WOMEN OF ILOILO CITY 2024 Iloilo City Gender and Development Program

RATIONALE:

The month of March is National Women's Month and the Iloilo City Government thru the leadership of Mayor Jerry P. Treñas under its Gender and Development Program together with office of the Committee on Women and Family Relations and the Iloilo Gender and Development Team is launching the search for Ten Outstanding Women of Iloilo City (TOWIL) 2024. The objective of this project is to give due recognition to women who have manifested exemplary performance in their particular field of profession that significantly brought honor/prestige to Iloilo City and its development.

GUIDELINES:

I. QUALIFICATIONS

The search is open to all women of legal age, who has made a major impact/contribution and has given pride and honor to the City of Iloilo. She must be a resident of Iloilo City and a person who has made significant accomplishments in any field of endeavor and has contributed to the empowerment/upliftment of the status of women and promoting of a gender fair society in Iloilo City.

II. MECHANICS

- 1. The Iloilo City GAD Focal Team announces the launching of TOWIL search for the year and nomination forms are distributed to various government, civic and non-government organization.
- 2. A search committee composed of Civil Society Organization representatives, members of Iloilo City GAD Focal Team is organized for the Ten Outstanding Women of Iloilo City Project, to take charge of the nomination process.
- 3. The TOWIL Screening Committee shall convene at a scheduled date to review and screen the nominations based on the criteria.
- 4. The nominations shall be based according to any respective fields of profession or endeavor such as: judicial services, academe, volunteerism and community services, religious services, professional services, culture and arts, math, science and technology, business, CSO and civic organization, media, government services and philanthropic works.
- 5. Submit the nomination form duly signed by the nominator and nominee together with the outstanding accomplishments or exemplary norms of conduct. Presentation of write-up should be in order of significance and complete with description/justifications and documentations maximum of 12 pages legal size, arial font size 12.
- 6. Winners shall be notified through emails and are requested to submit a half body 4R size picture after confirming their acceptance of the award.
- 7. Announcement of winners will be done 10 calendar days before the awarding ceremony.
- 8. The awardee and the nominator should be present during the awarding ceremony. The award will not be granted by the 2024 TOWIL Organizing Committee if the awardee could not attend the awarding ceremony. No proxy is allowed during the awarding ceremony.
- 9. The former TOWIL awardee can no longer be nominated/qualified to join.
- 10. TOWIL Screening Committee shall not entertain any form of protest after the decision has been made. The decision of the board of judges is final.
